

Terms of use

These Terms of Use (hereinafter "the Terms") regulate the operation of this website (hereinafter "the Website"), determine the terms of use of the materials and services of the Website. The site administrator provides information about themselves as well as contact information for site feedback. These Terms are in accordance with the applicable legislation of the Republic of Serbia.

Performing arbitrary actions of natural or legal persons (hereinafter "User") for the purpose of using the Website is considered unconditional acceptance of these Terms of Use of the site. The User hereby confirms that acceptance of these Terms is equivalent to signing and concluding the Agreement under the conditions indicated below.

Terms of use of the site

- The use of any material and services of the Website is regulated by the applicable legislation of the Republic of Serbia. The materials and services of the website are intended exclusively for their lawful use.
- 2. The user has the right, at his own discretion, to familiarize himself with the materials of the website and the services of the website.
- 3. The User agrees to use the Website without violations the rights of third parties, as well as prohibitions and restrictions established by applicable law, including without limitation: copyright and related rights, trademark rights, service marks and marks of origin, industrial design rights, the rights to use images of persons, as well as any actions that cause or may lead to disruption of the normal operation of the Website and the Website Services, in particular by means of programs that interfere with or attempt to disrupt the normal functioning of the Website.
- 4. Use of material from the Website without the consent of the copyright holder is not permitted. The lawful use of the site materials requires the consent of the site administrator or copyright holder of the materials.
- 5. If technically possible, the User has the right to post comments and other entries on the Website. The User guarantees that comments or other entries do not violate applicable law, do not contain materials of an illegal, indecent, defamatory, threatening, pornographic, hostile nature, as well as containing harassment and signs of racial or ethnic discrimination that call for actions that could be classified as criminal offenses,



as well as for other reasons unacceptable, materials that promote the cult of violence and cruelty, materials that contain obscene expressions. The administration of the website does not undertake to carry out preliminary moderation of materials and records on the website by the user. For comments and entries on the Page left by the User, the User is solely and fully responsible.

- 6. The site administrator is not responsible for the user's visit and use of external resources, links that can be reached on the site, and the user follows the links that are on the site to external sources, at its own discretion.
- 7. The User agrees that the Website Administration is not liable to the User in connection with any possible or suffered losses or losses related to any content of the Website, goods or services available on the Website or obtained through external websites or resources or other contacts of the User who came using data published on the site or links to external resources.
- 8. By providing in any form (registration on the website, subscription to advertising by mail, etc.) his personal data to the website manager, the user agrees to the processing of personal data by the website manager in accordance with the directive related to Law on data protection of Republic of Serbia. The processing of the User's personal data is also regulated by the valid legislation of the Republic of Serbia.
- 9. The administrator of the website has the right to change the content of the website, as well as to change the terms of use, unilaterally at any time, without notifying the user. Such changes are effective from the date of publication of the new version of the Terms of Use on this page. The current version of the Terms of Use is always on this page. In order to avoid disputes regarding changes to the Terms of Use, the site administrator recommends that you periodically review the content of the Terms of Use contained on this page. If the user does not agree with the changes made, he may refuse to use the website.
- 10. The site administrator has the right to unilaterally restrict the user's access to the site, if it is reasonable to believe that the user is carrying out illegal actions. In addition, the administrator has the right to delete User Materials at the request of authorized parties or interested parties if such materials violate the applicable law or the rights of third parties.
- 11. The Site Administrator and the User are responsible for non-fulfillment or improper fulfillment of their obligations in accordance with these Terms of Use of the site and the applicable legislation of the Republic of Serbia. The site administrator is not responsible for technical interruptions in the operation of the site, however, the site administrator undertakes to take all reasonable measures to prevent such interruptions.
- 12. All possible disputes arising from or relating to these Terms of Use of the site will be resolved in accordance with the applicable legislation of the Republic of Serbia.



- 13. The administrator has the right to suspend the operation of the website, partially or completely terminate access to the website until the completion of the necessary maintenance and (or) modernization of the website.
- 14. By taking actions to accept these Terms of Use of the site, the User guarantees that he is familiar with and agrees with them and that he fully and unconditionally accepts all these Terms in full, and undertakes to comply with them.
